Total Expenditures per Pupil



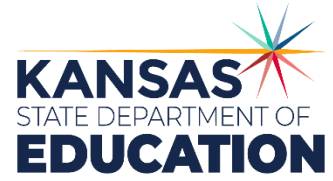

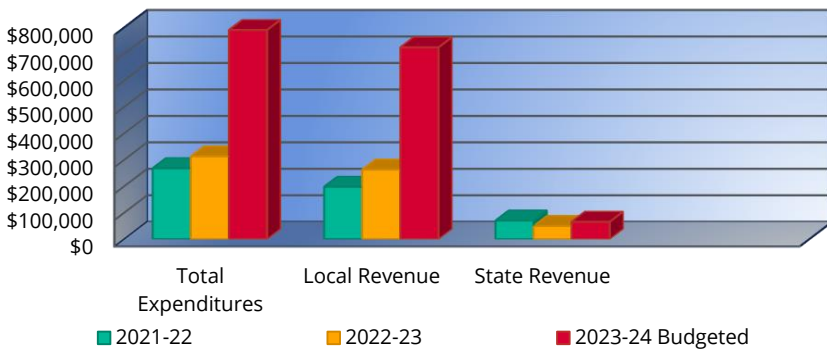

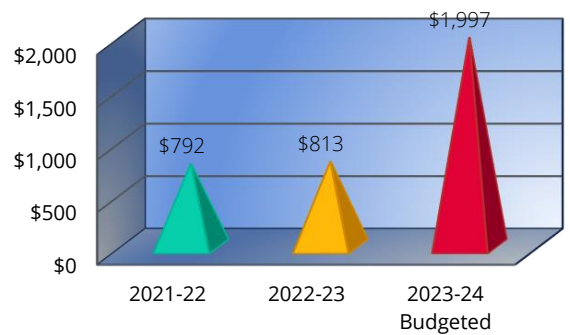

Total Expenditures



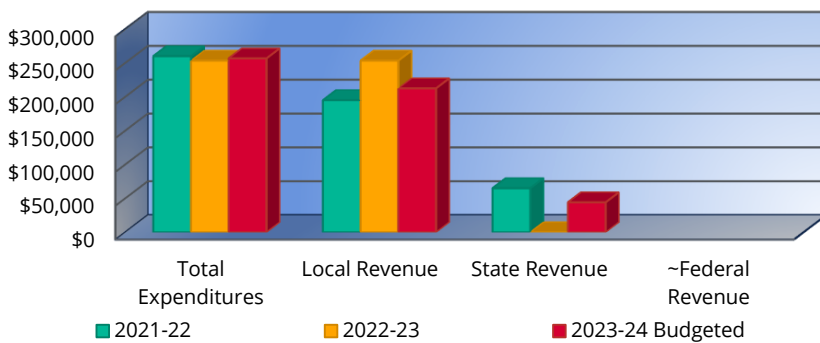
Total Expenditures per Pupil



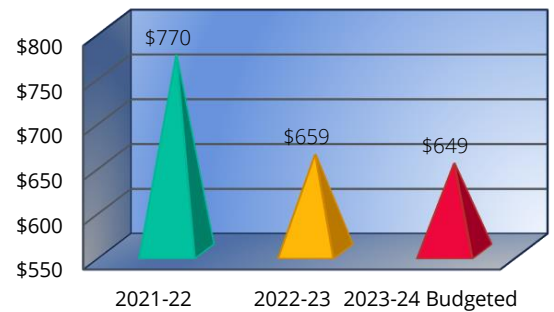

Total Expenditures per Pupil

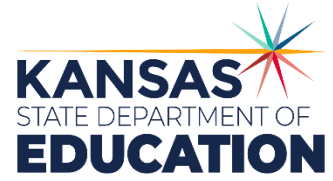

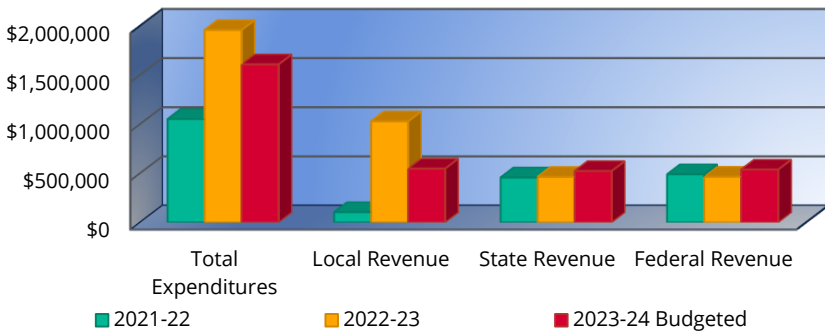

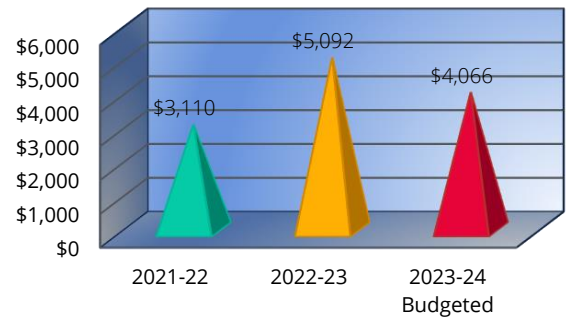

Total Expenditures



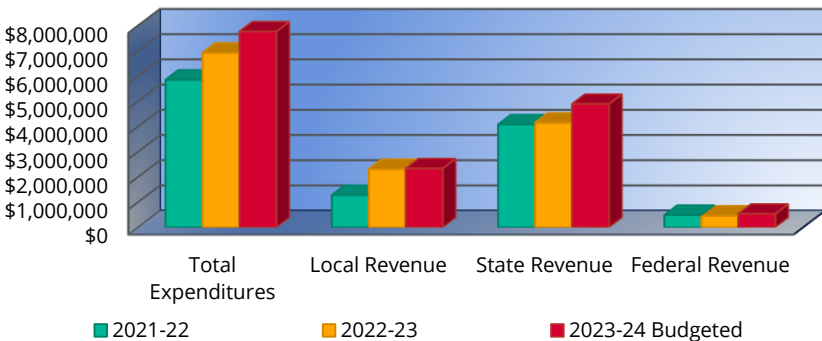
Total Expenditures per Pupil



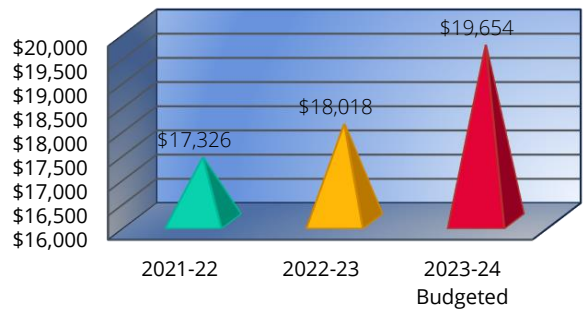

Total Expenditures



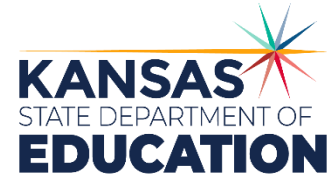
Total Expenditures per Pupil

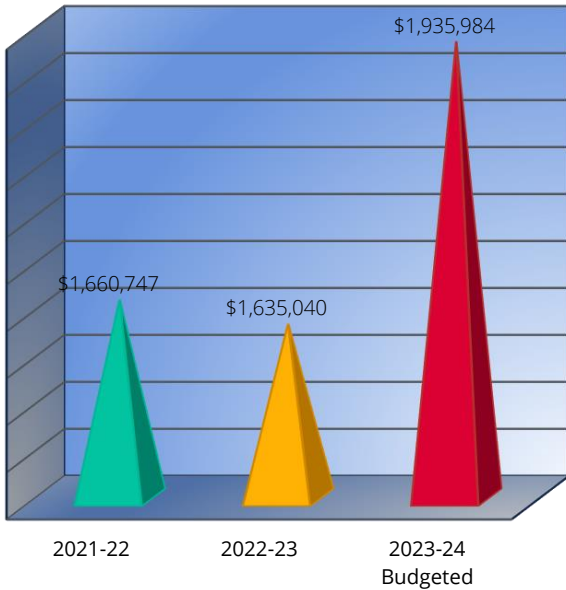

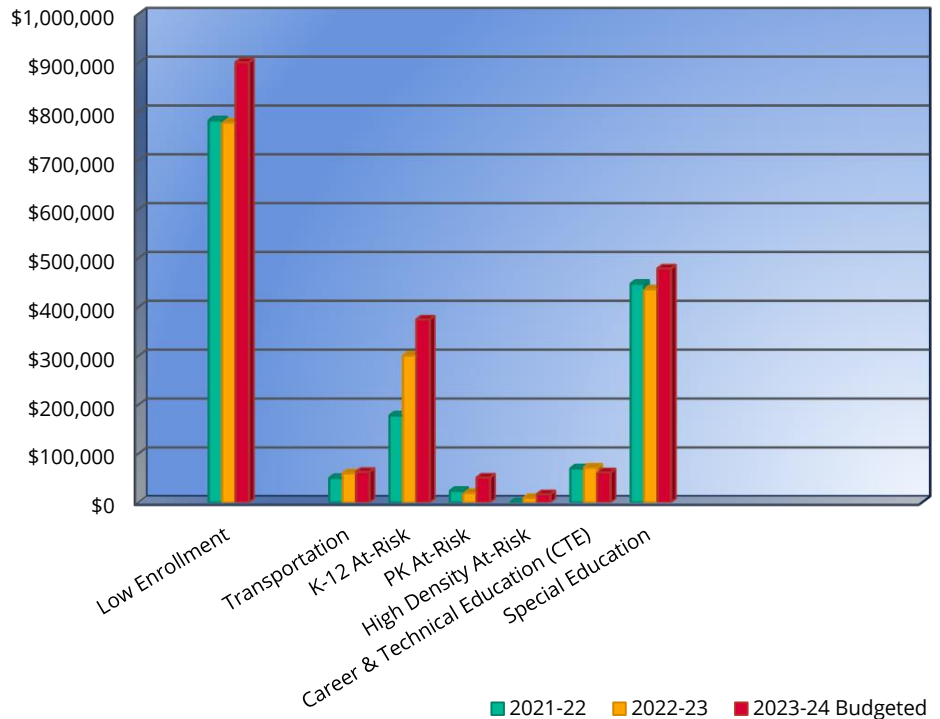

BASE State Aid



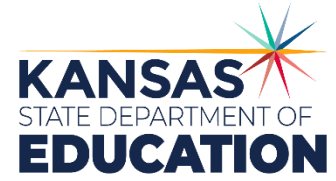

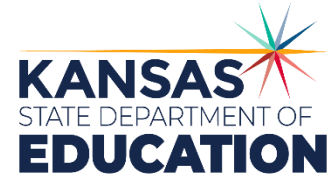
